## President's Report:

- The Annual Meeting has been confirmed for Thursday, November 30, 2017. A
  December meeting will not be held.
- The board is starting the process of converting a dead-end street in Phase 4 into a cul-de-sac in order to keep future neighborhoods from tying into the street and increasing traffic problems.
- There are multiple homes that have recently sold in Phase 3B where the doors do not
  match the shutter color. Ryan Homes has been notified of the issue and is in the process
  of resolving the issue.
- After working on gathering multiple bids, the board has agreed to pay ABCO Electric to perform the necessary work to fix the monument lights at the front entrance for an estimated cost of \$4,800.

- Due to dark conditions in the evening, the board is gathering estimates for installing two



street lights on the walking trail between Holly Oak Ln and Cherry Bark Oak Ct.

 The board has discussed the idea of waiving the Capital Contribution that is made by a homeowner when a second (or more) lot is purchased within Bethesda Oaks, and has agreed not to pursue the change at this time.
