- Uneven sidewalks are being repaired throughout the entire neighborhood. The work will be conducted in two phases (first crew tears out the sidewalk sections and the second crew comes and pours new sidewalk sections).

- Estimates will be obtained to pressure wash and seal all walking trail wooden bridges to remove the mold that is causing slippery surfaces.
