# **Landscaping Committee's Report:**

- Rock erosion problems cemented for permanent stability
- RFP are in process for community wide landscaping
- Addition of Phase 3 & Phase 4 to landscaping contract
- Replace the trees and sod that has been damaged due to construction traffic
- When growing season starts, landscaping picks up in March/April
  - QLM knows where to go for new areas



- Current companies bidding on the contracts are for entire community (phase 3 & 4)
- Drains clogged with debris from construction has been addressed
- Bill looking into clearing out silt bags from under storm drains
