#### President's Report:

- Speed-Detecting RadarSign Poll Emailed out to Community for Input/Suggestions
  - Still open for responses
  - Speed Humps
    - 2018 Speed Solutions Survey resulted in little support for speed humps and large support for speed-detecting radar signs.
    - City Requirements for Speed Humps (<u>see # 9 & 11</u>)

- Due to aging, Phase 1 & 2 walking trail bridges are scheduled to be pressure washed, then inspected for repairs (loose boards/nails, etc).

- Street Tree Heightening project started today
- Landscape Contract updates:
  - Committee met to review the top 3 vendors and gave their selection recommendation to the Board that we continue our partnership with QLM for another year, which the Board agreed with.
  - Detailed contract update made by the committee (includes <u>detailed aerial photo</u> <u>map</u> clearly defining every piece of common area in all 4 phases)
  - A Detailed 12-page Contract has been sent to the vendor and we are awaiting a fully signed & executed contract.

# Pool/Playground Committee's Report:

- Pool Updates:
  - New large metal sign with updated pool rules has been installed on the pool house.
  - New chaise lounges & umbrellas (backup in case of breakage) purchased.
    - Umbrellas are in storage room
  - Fire Marshall inspection completed on June 17:
    - Out of compliance items being addressed within 10 business days by July 1 (ex: fire extinguisher maintenance & inspection)
      - Nichole reached out to Reliable Fire Equipment and has them on a regular inspection schedule
        - Purchased one more fire extinguisher and a chlorine placard for the pump room door, and blanks in the breaker box that needed to be replaced (to be fixed over the weekend).
  - Outdoor shower at pool has been repaired after a breakage/leak on June 11
- Playground Updates:
  - Rubber mulch, over time, gets kicked onto the playset steps/platform. Our Landscape vendor has graciously agreed to periodically blow off the play structure when they come through to mow the surrounding common areas.
  - Update on the safety rail for top bridge: order status update is that it has arrived



in the US. Now tracking when it will arrive to the shop.
