- Lennar (Phase 4)

- S. New Hope Road Farmland
 - As discussed in our last meeting, the NewStyle Communities, Inc. easement option agreement has been signed. They have the option to exercise the easement option within 365 days.

- 2nd Speed RadarSign
 - All parts arrived, still waiting on City Encroachment agreement to be signed by city.
- 4th Amendment to the CCR on Rental Restrictions
 - Officially PASSED as of this week!
 - 257th vote FOR the amendment received on September 28, 2021, which satisfied the required 67% majority vote in order for the amendment to pass.
 - Amendment was certified, signed, notarized and recorded at the Gaston County Courthouse on September 29, 2021.
 - The 4th Amendment and Reasoning document have been posted to the bethesdaoaks.com web site as well as the CINC web site used by PMR.
