President's Report:

- Lennar/Phase 4:
  - Lennar continues to finish up their common area development before they exit.
  - Dead trees in Phase 4 **will be replaced** by Lennar, in addition to other landscaping before they exit.
  - Construction continues on the ADA Compliant winding walking trail in Phase 4.
  - Retention pond conversion still underway (plantings, fences, etc).
- NewStyle Communities development (adjacent to Bethesda Oaks on S. New Hope Rd)
  - Last August the HOA signed an **option agreement** with NewStyle to grant them easement access over our strip of land on City Church St.
    - On July 3, 2022 NewStyle executed their option for the easement. This means NewStyle is moving forward with their development, as you can see if you've driven past.

Finance Committee's Report:

• Reviewed all outstanding financial highlights since the last meeting.

Architectural Review Committee's Report:

- Violation letters were sent out as needed by Property Matters Realty.
- Approvals (if any) were reviewed and handled as needed.



Communication Committee's Report:

• Speed sign data generated for recent months ending in June 2022.

Landscaping Committee's Report:

- A portion of a tree fell at the Titman Road entrance. After inspection the tree was found to be dead/rotten, and thus had to be completely removed to prevent the rest of the tree from falling into the roadway.
- The Landscaping Committee and BOD are working with QLM to update/revise the landscaping contract for the next year's contract.

Pool/Playground Committee's Report:

- Pool water discoloration issue in July/August has been remediated by Perry Pools and water clarity appears to have returned to normal.
- Security Camera system expansion underway to help protect new Playground investment and cover far end of Pool/Playground area.
