- Lennar (Phase 4)
 - Nearing completion of Phase 4. What's left:
 - Retention ponds
 - New walking trail landscaping on Sand Post Oak
 - HOA is working with Dragonfly Ponds vendor and Lennar to get retention ponds completed to a standard that the HOA can accept responsibility for.
 - Lennar removed dead street trees and will be planting new trees within the next few weeks.
 - Lennar is bringing all irrigation systems up to order throughout Lowell Bethesda entrance.
 - o Likely exit/turnover date is November/December.

 - Budgeted project for this year is underway to replace outdated/faded & missing



- signs throughout the community.
- Plan is to replace old signs and install new decorative signs with consistency throughout the community.
- Awaiting tentative completion date from Image 360 (sign vendor).
- Concrete Walking Trail Project
 - Final stage of walking trail project complete with backfilling around all new concrete walking trail sections.
